At the same time, the cost of goods sold increased more than VND 8.7 billion compared to the same period of last year, causing gross profit increase more than VND 700 million, equivalent to about 102% of the same period last year.

Profit after tax in the 1st quarter of 2025 increased compared to the same period of last year, mainly due to an increase of Financial income more than VND 3 billion compared to the same period due to Income from joint venture investments.
